

## Hiroshima Love It Consortium Slack Terms of Service Established on January 21, 2004

### **Article 1 (Purpose)**

These Terms of Use are defined by the Hiroshima Love It Consortium (hereinafter referred to as the "Consortium"). With regard to Slack operated by the Consortium to promote Open Innovation, companies, organizations, local governments, universities, individuals, experts, etc. participating in the Consortium (hereinafter referred to as "Members"). It stipulates the contents necessary for use.

### **Article 2 (Service Contents)**

Members shall use the following channels managed and operated by the Consortium (hereinafter referred to as "Secretariat Various Channels"). It can be freely viewed or posted.

- (1) Anything Lounge
- (2) Consultation Channel for Concerns
- (3) Researcher Investment Consultation Channel
- (4) International Expansion Consultation Channel
- (5) On-campus Consortium Channel
- (6) Public Fund Acquisition Channel
- (7) Other channels that the Consortium believes will contribute to the promotion of open innovation

2 Members shall use the necessary channels (hereinafter referred to as "Member Channels") based on the Member's judgment That. can be freely constructed, deleted, viewed or posted

3 Members may use the various channels of the Secretariat and the various channels of members only within the following number according to the membership type stipulated in the Hiroshima Love It Consortium Rules.

- (1) Bronze Member can use 1 account
- (2) Silver Member can use 3 account
- (3) Gold Member can use 5 account.

4 Bronze Member as stipulated in the Hiroshima Love It Consortium Terms and Conditions may be newly established or deleted only for one channel limited to channels with restricted viewers (hereinafter referred to as "Private Channels") ,however, this channel must include Hiroshima University, which is the secretariat of the Consortium. Silver and Gold members may freely establish or delete private channels, including Hiroshima University, which is the secretariat of the Consortium

### **Article 3 (Compliance)**

Members shall comply with the following regarding the use of various channels.

- (1) In addition to these Terms, comply with the contents of the "Hiroshima Love It Consortium Agreement" separately stipulated separately and the "Use Policy" published by Slack Japan Stock Company on the website
- (2) Understand the purpose of the services provided by the Consortium and post information within a range that can be viewed by other members (however, this does not apply to private channels).

(3) The authority to establish or delete the various channels of the Secretariat shall be vested only by the Planning Group of the Academic and Social Collaboration Department, Hiroshima University Academic and Social Collaboration Office, which is the secretariat of the Consortium

(4) Appropriately manage the use and management of IDs and passwords acquired at the time of membership registration

(5) At the time of posting to the various channels of the Secretariat and the various channels of the Members, rights under the Copyright Act, such as reproduction, public transmission, distribution, translation, adaptation, etc. of the post in Japan and overseas (including the rights stipulated in Articles 27 and 28 of the Copyright Act) shall be deemed to have been transferred to the Consortium free of charge

#### **Article 4 (Prohibitions)**

Members are prohibited from engaging in the following acts in relation to the use of various channels.

(1) Acts of entering or disclosing false or inaccurate information

(2) Confidential information (including but not limited to information on innovation) or personal information shall not be disclosed, disclosed, provided, or leaked

(3) Criminal acts or acts that lead to violations of laws and regulations, acts that slander or slander, acts contrary to public order and morals, acts that interfere with the operation of various channels

(4) Acts of letting a third party use or transfer the acquired ID and password

(5) Other acts that lead to the Consortium judging that it is inappropriate to continue to provide the Service

(6) Launch a private channel without including Hiroshima University, which is the secretariat, as a member.

#### **Article 5 (On the authority of the Hiroshima Love It Consortium)**

If the Consortium determines that a Member's Submission or the management and operation of the Member Channels violates these Terms, the Consortium may, without prior notice, process the following with respect to the content of such posting, suspend the use of all services operated by the Consortium or terminate the Service Agreement. In addition, even if any damage or disadvantage occurs to the member due to such discontinuation of posting, Hiroshima Love It Consortium shall not be responsible for any way.

(1) To review the contents

(2) To delete the posted content

(3) To modify it and post it on the various channels of the Secretariat and the various channels of the Members

(4) To delete the various channels of the member and the private channel

#### **(Supplementary provision)**

1 These Terms of Use shall come into effect on January 21, 2004.
